

Ogow Xaqiiqooyinka ku saabsan Gargaarada Dowladdeed

(Xaashidan xaqiiqdu beddel uma noqonayso oo ma aha mid dhanka sharciga ah.)

Waxaa jira xeer federaal oo cusub oo beddelaya sida dadka loo arko inay yihiin kuwa helaya Gargaarada Dowladdeed “Public Charge”. Wuxuu waaxda socdaalka ee federaalka u oggolaadaa in ay fiiriso liiska dheer gargaarada dadweynaha, iyo arrimo badan sida dakhliga qoyska, marka la go'aaminayo haddii qofku u badan yahay in uu noqdo qof mustaqbalka helaya Gargaarada Dowladdeed “Public Charge”. Xeerkan cusub ma dhaqan gelayo ilaa laga gaarayo Oktoobar 15, 2019, xeerkuna ma aha mid muddo hore la oggolaaday, sidaa darteed wixii gargaaro ah ee cusub ee lagu daray lama bilaabo doono in loo xisaabiyo dadka ilaa laga gaarayo Oktoobar 15-keeda.

***Macluumaad cusub:** Garsoorayaasha federaalka ayaa joojiyay/xannibay xeerka gargaarada dowladdeed ‘public charge’ ee cusub. Ma uusan dhaqan gelin Oktoobar 15, 2019. Ma garanayno goorta xeerka la dhaqan-gelin doono. Ilaha ka fiiri bogga 2 si aad u ogaatid macluumaadka cusub ee hadda jira.

Xeerka gargaarada dowladdeed ‘Public Charge’ oo cusub MA AHA mid khuseeya qof kasta. Muhaajiriin badan oo u qalmaha gargaarada dadweynaha ayaa laga dhaafay daraasadda lagu sameynayo dadka qaata Gargaarada Dowladdeed “Public Charge test”.

Guud ahaan, xeerku wuxuu kaliya khuseeyaa:

- Dadka doonaya inay galaan ama dib ugu galaan Maraykanka.
- Dadka dalbanaya in ay u wareegaan oo helaan Sharciga Deganaanshaha Rasmiga ah (LPR ama kaarka deganaanshaha haysta “green card”) ama
- Dadka codsanaya kordhinta/dib u cusbooneysiinta fiisaha.

Kuwani waa qaar ka mid ah noocyada muhaajiriinta oo ay tahay **in aysan** ka walwalin Gargaarada Dowladdeed “Public Charge”,

ilaa iyo inta aysan ka bixin Maraykanka muddo ka badan 6 bilood:

- Qoxootiga
- Magan gelyo doonka
- Kuwa isla haddaba ah LPRs (kaarka deganaanshaha haysta “green card”) oo ay ku jiraan kuwa dib u cusbooneysiinaya kaarkooda LPR
- Xeerka Rabshada Ka dhanka ah Haweenka ee dadka iskood si gaar ah codsi u gudbinaya
- Kuwa codsanaya/fiisooyinka T ama U (dadka ka badbaada ka ganacsiga dadka, rabshada qoyska, ama dembiyada kale)
- Dhalinyarada muhaajirka ah ee gaarka ah
- Qoysaska xubnaha shaqada ciidan haya, iyo dadka kale.

Xeerka cusubi waa mid caddeynaya in gargaarada ay helaan kaliya xubnaha qoyska ee muhaajirka (carruurta ama kuwa kale) AANAN la xisaabinayn in lagu jiro daraasadda lagu sameynayo dadka qaata gargaarada dowladdeed “public charge test” ee muhaajirka.

Xeerka Gargaarada Dowladdeed ‘Public Charge’ oo cusub KUMA jiraan dhammaan gargaarada dadweynaha. Haddii aad ka mid tahay muhaajiriinta tirada yar ee ay tahay in ay ka walwalaan Gargaarada Dowladdeed “Public Charge”, xusuusnow in ay jiraan gargaarada qaarkood oo muhiim ah oo aanan la xisaabinayn daraasadda lagu sameynayo dadka qaata Gargaarada Dowladdeed “Public Charge test” (*fiiri shaxanka ku taala dhinaca dambe*).
